CONTRIBUTOR'S LICENSE AGREEMENT

This Agreement is entered into as of (date) by and between Floricanto Press, (the "Publisher"), and (the "Contributor") with respect to a descriptive work presently entitled: **DESDE EL BARRIO** (the "Work").

1. Grant of Publication and Additional Rights.

The Contributor grants to the Publisher, during the full term of copyright of the Work and all renewals and extensions thereof, the following rights to the Work and a photo of Contributor :

- (a) The sole and exclusive right to print, publish, and sell the Work and a photo of The Contributor in print or digital form in the English language in the United States, its possessions and trade partners.
- (b) The right to license Braille transcriptions, photocopying, microfilm, microfiche and reproduction or utilization in an information storage and retrieval system; non-dramatic recorded readings of part or all of the Work, including filmstrips, sound filmstrips, transparencies, slides, television cartridges and programs for teaching machines; and production or utilization in any form by any mechanical, electronic, or other means, now or hereafter invented;

2. Contributor Warranties. The Contributor represents and warrants to the Publisher that:

- (a) The Contributor is the sole author and proprietor of the Work.
- (b) All material of whatever kind, written, prepared, created, composed and/or submitted by the Contributor hereunder or to the Publisher:
 - (i) Shall be wholly original with Contributor and not in the public domain;
 - (ii) Shall not heretofore have been published in book form;
 - (iii) Shall not be copied in whole or in part from any other work;
 - (iv) Shall not contain any matter which is scandalous, obscene, libelous, an invasion of privacy or otherwise contrary to law, and
 - (v) Shall not infringe upon any statutory copyright, proprietary, common law or other personal property right whatsoever of any person, firm or corporation;

3. Right to Publish.

The Publisher shall have the right to publish the Work at its own expense, in such style and manner and at such price as it deems best, and may keep the Work in print as long as it deems expedient; but it will not be responsible for delays in publication caused by circumstances beyond its control, market conditions, or prospects that the publication may not be as profitable as expected.

4. Copyright.

(a) Upon publication of the Work of The Contributor, the Publisher shall, at its own expense, apply for a copyright of the Work and a photo of The Contributor in the name of the author in conformity with the Copyright Law of the United States and the Universal Copyright Convention and shall preserve and record such ownership in compliance with Title 17 of the United States Code and with such foreign statutes, treaties and conventions, as it, in its sole discretion, considers necessary and appropriate, including but not limited to duly affixing to each published copy of the Work the copyright notice required by law.

(b) The Publisher shall have the sole and exclusive right to publish the Work during the full renewal period upon the same terms and conditions as herein set forth.

5. Infringement.

(a) The Publisher shall have the sole and exclusive right, but not the obligation, to prosecute an action for infringement of any of the copyrights obtained by the Publisher with respect to the Work.

- (i) The CONTRIBUTOR shall not be called upon to bear any part of the expenses of the litigation;
- (ii) The Publisher shall give the CONTRIBUTOR not less than fifteen (15) days' written notice prior to commencing such litigation, and the CONTRIBUTOR shall have the right, in lieu of being made co-plaintiff, to assign within said fifteen (15)_day period the copyright to enable the Publisher to prosecute the litigation;
- (iii) In the event that the THE CONTRIBUTOR so assigns the copyright, the THE CONTRIBUTOR shall NO equitable ownership thereof; upon termination of the litigation, and
- (iv) If the Publisher recovers a judgment in any such litigation, the proceeds thereof, by settlement, judgment, or otherwise, less all expenses incurred by the Publisher, shall be the Publisher's alone

6. Promotion.

The Publisher may use and authorize use of the THE CONTRIBUTOR 's names, likeness and photograph in connection with advertising, publishing, licensing and promoting the

Work only with the express permission of the THE CONTRIBUTOR . The publisher shall include the work in his website, mailings, promotional efforts, and in printed and digital catalogs and listing as it is appropriate.

7. Royalties.

The Publisher shall not pay the Contributor any royalties for this license or release. The Contributor shall not receive any royalties with respect to any use of the Work that the Publisher may authorize without charge, in any form, including publication, by the Publisher or others:

- (i) to promote the sale of the Work and a photo of Contributor ;
- (ii) for the blind or physically handicapped;
- (iii) for educational or noncommercial television.
